# **Coverage Options**

## **Combined Professional Liability and General Liability**

## Option 1

Professional Liability (Claims Made Form) \$1,000,000 per claim / \$2,000,000 aggregate General Liability \$1,000,000 per claim / \$2,000,000 aggregate Annual Cost \$161

## Option 2

Professional Liability (Claims Made Form) \$2,000,000 per claim / \$4,000,000 aggregate General Liability \$2,000,000 per claim / \$4,000,000 aggregate Annual Cost \$198

## **Commercial General Liability**

#### Option 1

General Liability (Occurrence Form) \$1,000,000 per claim / \$1,000,000 aggregate Annual Cost \$102

## Option 2

General Liability (Occurrence Form) \$2,000,000 per claim / \$2,000,000 aggregate Annual Cost \$155

All premiums noted above are subject to applicable provincial tax: Ontario 8%, Quebec 9%, Manitoba 7%, Saskatchewan 6% and Newfoundland 15%, other provinces are not subject to tax.

# **Coverage Details**

#### **Professional Liability Insurance**

Professional liability insurance protects you against liability, or allegations of liability, for injury or damages resulting from a negligent act, error, omission, or malpractice that has arisen out of your professional capacity as a holistic nutrition professional.

## **Commercial General Liability Insurance**

Commercial general liability insurance, protects members from financial loss should they be sued due to property damage, injury, or death caused by your services, business operations, or your employees (not specifically related to your delivery of professional services, which is covered by your professional liability coverage).
